## ORDER DENYING REQUEST FOR REINSTATEMENT

On November 14, 2001, the Medical Examining Board (Board) issued its *Final Decision and Order* in the above-captioned matter. Under the terms of that Order, Ms. Zwier's certificate to practice as a respiratory care practitioner was limited. The Order provides, in part, that before Ms. Zwier may practice in Wisconsin she must first provide acceptable proof to the Board of quarterly work reports from her supervising employer and written verification from the educational provider that indicates she has completed her required continuing education. To date, Ms. Zwier has not provided any such proof. Therefore, based upon the Board's review,

IT IS HEREBY ORDERED that the request of Debra A. Zwier to be restored to full certification is DENIED.
