On March 4, 2004, Pursuant to the Order currently in effect against HOLLY B. LAVOIE, the Board of Nursing considered the petitioner's request for a further three month stay of the suspension. LaVoie's petition disclosed that she had not been compliant with the drug and alcohol screening requirements of paragraph 7 of the Order. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for stay of the suspension of the license of HOLLY B. LAVOIE, (#119837) to practice as a registered nurse in Wisconsin is hereby DENIED and the license is hereby SUSPENDED until further notice of the Board.

IT IS FURTHER ORDERED THAT the Petitioner shall not request a stay of her suspension until she has shown three months compliance with the Order.
