ORDER GRANTING STAY OF SUSPENSION

On May 5, 2004, the State of Wisconsin Dentistry Examining Board reviewed the documentation submitted in support of the request by Dr. Moldenhauer for all of the following:

- (1) A six-month extension of the stay of suspension;
- (2) A reduction in the number of urine screens to fifteen (15) per year, but not less than once a month;
- (3) A reduction in the number of monthly therapy sessions; and
- (4) The termination of the mentor requirement.

Based upon the Board's review,

IT IS HEREBY ORDERED that the requests of Blair D. Moldenhauer, D.D.S., as noted above in Items 1-4 are DENIED.

IT IS FURTHER ORDERED that Dr. Moldenhauer be granted a three-month stay of the suspension of License #015-33331 to practice dentistry in the State of Wisconsin.

IT IS FURTHER ORDERED that Dr. Moldenhauer's license to practice dentistry remains subject to the terms and conditions as set forth in the Board's *Final Decision and Order* dated January 9, 2002, and any subsequent Board Orders.

Please be advised that the next submission of reports and the petition for an extension of a stay of suspension are due on June 15, 2004.
