On March 4, 2004, pursuant to the Order currently in effect against BARBARA J. BENOIT, the Board of Nursing considered the petitioner's request for a three month stay of the suspension of her limited license, termination of her therapy requirement and reduction in her urine screens. Based upon all information of record herein and upon a showing of compliance by the petitioner, the Board orders as follows:

#### **ORDER**

### NOW, THEREFORE, IT IS ORDERED that

- 1. BARBARA J. BENOIT is hereby granted a three month stay of suspension of license #82241 to practice as a registered nurse in Wisconsin.
- 2. The petitioner's request for termination of therapy requirement is hereby GRANTED. All other terms and restrictions imposed under the Board order dated November 11, 2003, shall remain in effect.
- 3. This Order is effective upon the date of signing below and is continuous from the time of the expiration of the previous stay.
