On June 24, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Lance J. Lundstad, for a three month stay of suspension as provided in the board's *Final Decision and Order* dated June 12, 2002. ("*Order*"). Also requested by Lundstad and supported by his employer was a request to increase his current hours worked as a pharmacist in charge an additional (8) eight hours per week, in addition to his current authorized amount of (8) eight hours, for a total of (16) sixteen hours per week. The board also reviewed correspondence dated April 14, 2004, from James Harrison, Section Chief, Depatment of Behavioral Health at Gundersen Lutheran Medical Center, indicating that Lundstad had not been in active therapy since January 26, 2004, but had an appointment scheduled for April 21, 2004.

Based upon the board's review,

IT IS HEREBY ORDERED that Lance J. Lundstad, R.Ph., is granted a three month stay of the suspension of license #12304 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that Lundstad's request to increase his current hours worked as a pharmacist in charge an additional (8) eight hours per week, in addition to his current authorized amount of (8) eight hours for a total of (16) sixteen hours per week, is denied.
