On Thursday, September 16, 2004, pursuant to the Order currently in effect against Patrick L. Skelton, the Board of Nursing considered the petitioner's request stay of the suspension in effect against her license. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petition of Patrick L. Skelton (license # 33864) for a continuance of stay of the suspension in effect against his license to practice as a registered nurse in the state of Wisconsin is GRANTED for a period of three months.

IT IS FURTHER ORDERED that Mr. Skelton's petition for a reduction of required drug screens is GRANTED, and screens shall hereafter be required on a frequency of fourteen [14] screens per year. All other terms, conditions and limitations affecting the petitioner's license shall remain in effect.

This Order is effective upon the date of signing.
