ORDER GRANTING THREE MONTH STAY WITH MODIFICATION LS0209055NUR

On December 9, 2004, the Wisconsin Board of Nursing considered the request of the petitioner, Robert O. Saess, R.N, for a further three month stay of the suspension, pursuant to the Order dated September 5, 2002, currently in effect against him. The petitioner also requested a decrease in his therapy requirements from one time per month in person to one time per quarter by telephone. Based upon all information of record herein, showing that the petitioner is in compliance with the terms and conditions of his limited license, but insufficient justification for the modification of his therapy requirement, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of the suspension of the limited license of ROBERT O. SAESS, R.N., (lic. #134724) to practice as a RN in the state of Wisconsin is hereby GRANTED for a further period of three months.

IT IS ORDERED that the request for a modification of his therapy requirement to quarterly sessions by telephone is DENIED. The order is modified to allow the petitioner to have his therapy sessions reduced to <u>one time per month</u>, provided that the session is to be conducted <u>face-to-face</u> with the therapist and <u>not</u> by telephone.

This Order is effective upon the date of signing.
