On December 9, 2004, pursuant to the Order dated September 5, 2002, currently in effect against the petitioner, James J. Piper, R.N., the Board of Nursing considered the petitioner's request for reinstatement of his license to practice as a registered nurse. Based upon all information of record herein, including the recent date of the petitioner's completion of the Sexual Offender Treatment (SOT) Program, and the petitioner's completion of only two years of his ten years of court ordered probation, the Board of Nursing orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the revoked license of JAMES J. PIPER, R.N. (lic.#127193) to practice as a registered nurse in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner shall not submit another request for reinstatement of his nursing license for twenty-four (24) months from the date of this order, and that during this period the petitioner shall obtain professional counseling and therapy from a certified specialist in sexual boundaries.

This Order is effective upon the date of signing.
