On September 15, 2004, the petitioner made his annual appearance before the Medical Examining Board, pursuant to the order dated September 2 5, 2002, currently in effect. At the time of his appearance, the petitioner requested a three month stay of the suspension of his license, a decrease in his drug screens, and a decrease in his therapy sessions. Based upon all information of record herein, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of JEFFREY T. JUNIG, M.D., to practice medicine and surgery in Wisconsin (lic.# 32668) is hereby GRANTED.

IT IS FURTHER ORDERED that the request for decrease in the drug screens from twice per month to once per month is DENIED.

IT IS FURTHER ORDERED that the request for a decrease in his group or individual therapy sessions from twice per month to once per month is GRANTED.

This Order is effective upon the date of signing and is continuous from the expiration of the previous stay.
