## STATE OF WISCONSIN BEFORE THE BOARD OF NURSING

RESPONDENT :

On October 4, 2002, the Board of Nursing entered its Final Decision and Order in the above-captioned matter. Under the terms of the board's Order, Ms. Powell's license was limited to require that she practice only in settings where she worked under supervision acceptable to the Board, and obtain approval of a work setting prior to commencement of nursing duties. She was also prohibited from working with ventilator-dependent patients. Within twelve months from the date of the order, Ms. Powell was required to submit acceptable documentation of successful completion of at least eighteen [18] hours of continuing education or of other training approved by the Board in the areas of legal aspects of documentation, pulmonary care, nursing ethics and responsibilities. Respondent also had to complete at least twelve [12] hours of continuing education or therapy in the areas of stress management and dealing with emergencies. For a period of at least one year from the date of the Order, Respondent was to arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance.

On December 5, 2003, the board granted Ms. Powell's request that the deadline for completing the continuing education requirement be extended.

On January 15, 2004, the board reviewed Ms. Powell's request for reinstatement of an unlimited license, having completed all the terms of the Order

## **ORDER**

NOW, THEREFORE, IT IS ORDERED that the license of Caley Powell, RN, number 64542, is restored to full unlimited status, and all right, title and privilege appurtenant thereto.
