On September 15, 2004, the petitioner made his annual appearance before the Medical Examining Board, pursuant to the order dated October 23, 2002, currently in effect. At the time of his appearance, the petitioner requested a three month stay of the suspension of his limited license. It was also reported to the Board that the petitioner's therapy sessions had been reduced after the first year of the stayed suspension from weekly sessions to twice per month, without a written petition for modification approved by the Board. Based upon all information of record herein, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of THOMAS J. STRICK, M.D., to practice medicine and surgery in Wisconsin (lic.# 27818) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner may continue receiving therapy on the current basis of two sessions per month, however, petitioner must abide by all other terms of his original order, unless a modification is expressly approved by the Board.

This Order is effective upon the date of signing and is continuous from the expiration of the previous stay.
