On May 14, 2003, the State of Wisconsin Pharmacy Examining Board reviewed evidence in the form of a police report of the City of Ripon Police Department, dated April 12, 2003, indicating that Oestreich was reported to be videotaped drinking alcohol while on duty as a pharmacist. The police were called by his employer. After a search of Oestreich's car, controlled substances were found as well as empty wine cooler bottles. After further police investigation, Oestreich was arrested for a violation of Wis. Stats. §§ 346.88(1), 943.50(1M), and 961.41 (3G), (A)1. His probation agent reported orally to the department monitor, Michelle Neverman, that Oestreich is currently being held as an inpatient at a psychiatric ward at a hospital in Oshkosh, Wisconsin. Accordingly, the Board revoked Oestreich's stay of suspension on May 14, 2003.

At its October 13, 2004, meeting, the Board reviewed a petition and supporting materials submitted by Oestreich in support of a request that the Board reinstate the stay of suspension in this matter. After review and consideration by the Board:

IT IS HEREBY ORDERED: that Duane A. Oestreich, is granted a three month stay of the suspension of license #8131 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the effective date of the *Order* and the commencement of the five years of compliant practice required thereunder is reset to October 13, 2004.
