Pursuant to the Order currently in effect against Lois Boyd, on March 4, 2004, the Board of Nursing considered the petitioner's request for a further three month stay of suspension. Also reviewed was a work supervisor report, indicating that Boyd had access to and administered controlled substances, which is prohibited by paragraph 17 of the Order. Based upon all the information of record, it is hereby ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petition of Lois Boyd to practice as an RN, APNP, in Wisconsin for a further period of three months, is DENIED.

IT IS FURTHER ORDERED: that the licenses of Lois Boyd to practice as a registered nurse, #94643, and as an advanced practice nurse prescriber, #1531, in the state of Wisconsin, are HEREBY SUSPENDED, based upon Boyd's violation of paragraph 17 of the Order.

This Order is effective upon the date of signing.
