On July 29, 2004, the Nursing Board considered the petition of Cheryl A. Boyer for reinstatement of full licensure. Based upon all evidence of record herein, the board orders as follows:

### **ORDER**

The petition for reinstatement of the limited license of Cheryl A. Boyer, to practice as a licensed practical nurse in the State of Wisconsin, license number 29506, is DENIED.

IT IS FURTHER ORDERED that the petitioner shall complete at least three (3) months of individual psychotherapy for anger management, as recommended by her therapist and submit a complete psychological evaluation from her therapist which includes an opinion on her fitness to practice prior t the granting of a petition for reinstatement.
