The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision in this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and finds it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Changing Faces, 2456 N. Grant Boulevard, Milwaukee, WI 53210, is currently licensed as a barber and cosmetology establishment in the State of Wisconsin (establishment license #30116). This license was first granted on November 5, 2001. Changing Faces conducted barbering and cosmetology services for several months in 2001 without a valid or current establishment license.
2. According to the Department of Regulation and Licensing records, Ronnie Lockett, 2456 North Grant Boulevard, Milwaukee, WI 53210, signed the October 2001 establishment license application for Changing Faces as manager of Changing Faces. Mr. Lockett is licensed in the State of Wisconsin as a barber and cosmetology manager (license #28388). As the listed manager of Changing Faces, Ronnie Lockett was at all times relevant to this action responsible for compliance with Wisconsin Statute, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters BC 2, 3 and 4.
3. Prior to November 2001, Changing Faces did not have a valid or current barbering and cosmetology establishment license.
4. During October and November 2001, Marilyn Brooks, Natalie Fowlkes and Robin Easter were employed at Changing Faces. Brooks, Fowlkes and Easter were providing barbering and cosmetology services to the public without valid or current Wisconsin barbering and cosmetology licenses.
5. In resolution of this matter, Ronnie Lockett consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Ronnie Lockett, manager, violated Wisconsin Statutes, Chapter 454.08(1)(b) and 454.08(3) and Wisconsin Administrative Code for Barbering and Cosmetology BC 2.04(1) and 2.07.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that:

1. **Ronnie Lockett** , shall pay partial cost in this matter in the amount of **ONE THOUSAND FIVE HUNDRED DOLLARS (\$1500.00)**.
2. **Ronnie Lockett** shall pay to the Department of Regulation and Licensing a forfeiture of **ONE THOUSAND** dollars (\$1000.00).
3. A Payment of \$500.00 shall be submitted within thirty (30) days form the date of this Order and payments of \$500.00 will be due on the first of every consecutive month there after until the full \$2,500.00 is paid. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:
Department Monitor, Division of Enforcement, Department of Regulation and Licensing , PO Box 8935, Madison, WI 53708-8935.

IT IS FURTHER ORDERED, that in the event **Ronnie Lockett** fails to timely submit payment of the forfeiture and cost as set forth above, the barber and cosmetology manager license of **Ronnie Lockett** SHALL BE SUSPENDED, without further notice or hearing, until respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
