On November 4, 2004, , the Board of Nursing considered the petitioner's request for reinstatement of full licensure or, in the alternative, a further three month stay of the suspension of her limited license, and for termination of her therapy requirement. Based upon all information of record herein, the Board finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of full licensure to Lori M. Cuene (Lic. # 94303) is hereby DENIED.

IT IS FURTHER ORDERED that the stay of the suspension of petitioner's limited license to practice as a registered nurse in Wisconsin is hereby GRANTED for a further period of three (3) months.

IT IS FURTHER ORDERED that the petitioner's request for termination of her therapy requirement is hereby GRANTED, with all other terms and restrictions imposed under the Board order dated November 11, 2003, to remain in effect.

This Order is effective upon the date of signing below and is continuous from the time that the previous stay expired.
