On December 9, 2004, the Wisconsin Board of Nursing considered the request of the petitioner, Lori M. Cuene, R.N, to surrender her license to practice in the state of Wisconsin as a registered nurse, prior to completion of the requirements of the Board order dated November 11, 2003, currently in effect. Based on the information presented, indicating that the petitioner is not intending to continue practicing nursing in Wisconsin for a period of time, the Board now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of the RN license (lic.# 94303) issued to Lori M. Cuene is hereby ACCEPTED.

IT IS FURTHER ORDERED that if the petitioner reapplies for licensure in the state of Wisconsin in the future, her nursing license would be subject to the modified requirements of the original Board order, which were not completed prior to her surrender. The petitioner has already satisfied the therapy and Nursing Refresher course requirements per the original order.

This Order is effective upon the date of signing.
