On June 10, 2004, pursuant to the Order currently in effect against Carol Majerowski, the Board of Nursing considered the petitioner's request for a further three month stay of the suspension. The Department Monitor presented evidence that Ms. Majerowski failed to disclose her limited license to her clients and failed to complete the standard therapy report and submit a current mental health status evaluation. Based upon all information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the limited license of Carol J. Majerowski, license number #125475, to practice RN in Wisconsin, is hereby suspended for a period of thirty (30) days beginning on June 10, 2004.

IT IS FURTHER ORDERED that the limited license of Carol J. Majerowski, license number #125475, shall thereafter be granted a stay of suspension for a period of two months beginning on July 11th. The petitioner is approved to resume work in a home health setting with her prior minor child client, but is not approved for additional home health clients at this time. IT IS FURTHER ORDERED that the Petitioner shall submit a current mental health evaluation to the Board, which includes an evaluation of her fitness to practice.
