On December 9, 2004, the Wisconsin Board of Nursing reviewed the petitioner's request for a three month stay of the suspension of his limited license to practice as registered nurse-anesthetist, pursuant to the original Board order dated December 5, 2003, currently in effect. The petitioner also requested a reduction in his therapy requirement. Based upon all information of record herein, which shows the petitioner's compliance with the terms and conditions of his original Board order, the Board now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for three month stay of the limited license of RICHARD D. MUNSTER, to practice as a registered nurse (#77189) and nurse-anesthetist, is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for reduction in his therapy to one time per month is GRANTED. There shall be no reductions in the level of urine screens.

IT IS FURTHER ORDERED that the petitioner must abide by the requirements in the original Board order, including production of a urine specimen within **five (5) hours** of a notification of the test and all other requirements set forth in paragraph #18 of his original Board order.

This Order is effective upon the date of signing.
