The parties in this matter agree to the terms and conditions of the attached Stipulation, subject to the approval of the Board. The Board has reviewed this Stipulati and considers it acceptable. Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Bruce E. Walley, RN (D.O.B. 03/28/56), is duly licensed in the state of Wisconsin to practice as a registered nurse (license #133330). This license was first granted on August 30, 1999.
- 2. Respondent's latest address on file with the Department of Regulation and Licensing is 14490A Old Indian Village Road, Lac Du Flambeau, WI 54538. Mr. Walley's last known address is 1081 Walleye Circle, Minocqua, WI 54540.
- 3. On or about August 21, 2001, the Wisconsin Board of Nursing imposed disciplinary action against the license of Respondent. Effective December 18, 2001, and at all times relevant to this action, Respondent's Wisconsin nursing license was suspended, pursuant to a December 18, 2001 Order of the Board, due to violations of the Board's August 21, 2001 Order.
- 4. Following December 18, 2001, and continuing on through March 24, 2002, Mr. Walley was employed as a registered nurse at K Care Our Home II, 12339 Warpath Lane, Minocqua, Wisconsin, without a current RN license and in violation of the Board's December 18, 2001 Order of suspension.
- 5. Mr. Walley consents to issuance of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board of Nursing has jurisdiction to act in this matter, pursuant to sec. 441.07, Stats.
- 2. The Board is authorized pursuant to sec. 227.44(5), Stats. to enter into the attached Stipulation and Order and impose the following terms and conditions.
- 3. Respondent's conduct constitutes a basis for action within the meaning of sec. 441.07(1) and 441.06, Wis. Stats., and Wis. Admin. Code §N7.04.

ORDER

- 1. The stipulation of the parties is approved.
- 2. The Board of Nursing accepts the surrender of the license of Bruce E. Walley, RN, (license #133330), to practice as a registered nurse in the State of Wisconsin.
- 3. In the event that Mr. Walley re-applies for Wisconsin licensure as a registered nurse in the future, the Board may enter an order denying such application without further notice or hearing.
- 4. This Order shall become effective upon the date of its signing.
