On June 21, 2004, the Nursing Board considered the petition of Colette Trotta for reinstatement of full licensure. The Department Monitor presented evidence that Ms. Trotta failed to request or obtain pre-approval form the Board for coursework relating to budgeting and management of personal finances as required in the Continuing Education provisions of the original Order. In addition, Ms. Trotta failed to provide the Board with a rehabilitation review assessment from the Department of Health and Family Services. Based upon all evidence of record herein, the board orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of full licensure of the Petitioner, to practice as a RN in the State of Wisconsin, license number #136257, is hereby denied.

IT IS FURTHER ORDERED that the Petitioner may not submit another request for reinstatement until she has completed her DHFS Rehabilitation Review.
