The Wisconsin Board of Nursing received a Stipulation submitted by the parties to the above-captioned matter. The Stipulation, a copy of which is attached hereto, was executed by Theresa C. McManus, R.N., personally, and by Claudia Berry Miran, attorney for the Department of Regulation and Licensing, Division of Enforcement. Based upon the Stipulation of the parties, the Wisconsin Board of Nursing makes the following Findings of Facts, Conclusions of Law, and Order.

#### FINDING OF FACTS

- 1. Thersesa C. McManus, R.N. was born May 12, 1962. Ms. McManus' latest address on file with the Department of Regulation and Licensing is 208 South Willow Street, Kimberly, WI 54136.
- 2. Ms. McManus is licensed to practice in the State of Wisconsin as a registered nurse pursuant to license #132410, which was first granted on July 2, 1999.
- 3. Two informal complaints naming Ms. McManus as respondent (99 NUR 075, 00NUR 050) are open with the Division of Enforcement.
- 4. Ms. McManus has been advised by her physician not to resume work as a nurse because of her health. She has therefore offered to resolve these complaints by the Voluntary

  Surrender of her registered nursing license.
- 5. The Division of Enforcement has indicated to the Board of Nursing that it has no objection to the resolution of this formal disciplinary matter by the Voluntary Surrender of the registered nursing license of Theresa C. McManus and the entry of the Order set forth below.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to sec. 441.07(1), Wis. Stats.
- 2. The Wisconsin Board of Nursing is authorized to approve the voluntary surrender of the registered nursing license of Theresa C. McManus as a resolution of these matters pursuant to sec. 227.44(5), Wis. Stats.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Voluntary Surrender of the registered nursing license of Theresa McManus, credential # 132410 is hereby accepted.

IT IS FURTHER ORDERED, that all rights and privileges heretofore granted to Respondent Theresa C. McManus pursuant to the registered nursing license #132410 are forever terminated effective at 11:59 p.m. on the date of this Order.

IT IS FURTHER ORDERED, that the Division of Enforcement files 99 NUR 075 and 00 NUR 050 be, and hereby are, closed.
