The parties having agreed to the attached stipulation, the Chiropractic Examining Board makes the following:

Findings of Fact

- 1. Harold Dykema, D.C., ("Respondent") was born on January 15, 1940, and was licensed to practice chiropractic in Wisconsin pursuant to license number 1253, granted on February 7, 1967.
 - 2. Respondent's license to practice chiropractic was suspended for a period of not less than six months, effective October 20, 2003.
- 3. On December 1, 2, and 6, 2003, Respondent performed chiropractic services for Patient TM at his office in Eau Claire, Wisconsin, and on December 17, 2003, Respondent filed a claim for payment for those services with Wisconsin Physicians Service Insurance Corporation.

Conclusions of Law

- 1. The Chiropractic Examining Board has jurisdiction in this matter pursuant to s. 446.03, Stats.
- 2. Respondent's practice of chiropractic and submission of a claim for compensation for those services during the term of the suspension of his license to practice chiropractic in the state of Wisconsin violates s. Chir 4.07, Wis. Admin. Code, and s. 446.02(1)(a), Stats.

Order

Now, therefore, the license previously granted to Harold Dykema, D.C., is SUSPENDED for an indefinite period.

It is further ordered that Harold Dykema, D.C., may not petition the Board for re-instatement of the license before September 15, 2004.

It is further ordered that Harold Dykema, D.C., shall pay the costs of this proceeding in the amount of \$754.13 to the Department of Regulation and Licensing within thirty days of this order.
