On November 4, 2004, the Board of Nursing considered the petitioner's request for a three month stay of the suspension of her limited registered nurse license (#147190), pursuant to the Board Order dated April 22, 2004, currently in effect. Based upon all information of record herein, including a report of the petitioner's failure to comply with her therapy requirements and the lab report of her positive urine screen for propoxyphene, a controlled substance, the Board of Nursing makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that

1. The request for a further stay of the suspension of the limited license of Elizabeth N. Hadlich (lic. #147190) to practice as a registered nurse is hereby DENIED. The reason for the denial of the request for a further stay is that the petitioner has violated numerous terms and conditions of the Order; including therapy not less than twice per week, drop screen notifications and abstinence from all personal use of controlled substances not necessitated by a legitimate medical condition and approved by her health care provider.
2. The petitioner shall have six (6) months of compliance with the terms of the original order before she may petition the Board for another stay of suspension.
3. This order is effective five days after the date signed below.
