The parties having agreed to the attached stipulation, the Medical Examining Board makes the following:

Findings of Fact

1. Marvin A. Schultz, M.D. was born on October 9, 1929, and is licensed to practice medicine and surgery in the state of Wisconsin pursuant to license number 12782, first granted on August 13, 1957. Dr. Schultz is a psychiatrist.
2. Dr. Schultz is physically impaired by Parkinson's disease and advanced microvascular disease in the brain.
3. Dr. Schultz has agreed to surrender his license to practice medicine and surgery due to his medical condition.

Conclusions of Law

1. The Medical Examining Board has jurisdiction in this matter pursuant to s. 448.02(3), Stats.

Order

Now, therefore, the Medical Examining Board accepts the surrender of the license to practice medicine and surgery previously issued to Marvin A. Schultz, M.D.

It is further ordered that Dr. Schultz may apply for reinstatement of his license when he has a neuropsychiatric evaluation acceptable to the Board demonstrating that his condition permits the practice of medicine and surgery.
