The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Grigory Sorokin, M.D., Respondent, date of birth March 7, 1965, has an expired Wisconsin medicine and surgery license number 20-34573. Thi license expired on October 31, 2003.
 - 2. Respondent's last address reported to the Department of Regulation and Licensing is 10601 N. Hayden Road #103, Scottsdale, AZ 85260.
- 3. On January 27, 2004, Respondent entered into a Plea Agreement with the Superior Court of Arizona, Maricopa County, wherein he pled guilty and was convicted of one count of attempted sexual assault, one count of sexual abuse and one count of attempted molestation of a child. The convictions involved sexual contact with three minor male patients. A true and correct copy of the Court Docket for Maricopa County Arizona is attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.
- 4. Based on the Plea Agreement referenced in paragraph 3 above, Respondent entered into a Consent Agreement for Surrender of License with the Arizona Medical Board on March 10, 2004. A true and correct copy of Arizona's Consent Agreement is attached to this document as Exhibit B. Exhibit B is incorporated in this document by reference.
 - 5. In resolution of this matter, Dr. Sorokin consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to sec. 448.02(3), Stats. and is authorized to enter into the attached Stipulation and Order, pursuant to sec. 227.44(5), Stats.
 - 2. The conduct described in paragraphs 3 and 4, above, constitutes a violation of Wisconsin Administrative Code §§ Med 10.02(2)(q) and (r).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the license of Grigory Sorokin, M.D., to practice medicine and surgery in the State of Wisconsin is hereby **REVOKED**, effective immediately.

The rights of a party aggrieved by this Decision to petition the Board for rehearing and to petition for judicial review are set forth on the attached "Notice of Appea Information".
