The Department of Regulation and Licensing received a Stipulation submitted by the parties to the above-captioned matter. The Stipulation, a copy of which is attached hereto, was executed by Heather Murphy Pollard, personally and by her attorney, William C. Yellin, and by Claudia Berry Miran, attorney for the Department of Regulation and Licensing, Division of Enforcement. The Department Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department Secretary adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Heather Murphy Pollard, 619 South College Avenue, Suite 11, Fort Collins, CO, is not and was not at any time relevant to this action licensed to practice medicine or pharmacy in Wisconsin.
- 2. From January 1999, to June 2001, Ms. Pollard owned and operated The Academy for Natural Health, a business located at 20611 Watertown Road, Waukesha, WI. At that location, The Academy for Natural Health shared a suite with Kenneth J. Kurt, DO.
- 3. In November 1999, with Dr. Kurt's consent, Ms. Pollard took samples of Arthrotec, a prescription drug, from a cabinet in Dr. Kurt's office and gave the samples to a client who was complaining of a stiff neck.
- 4. Wis. Stats. § 448.01 (9) (a) provides, in part, that practice of medicine and surgery means "To examine into the fact, condition or cause of human health or disease, or to treat, operate, prescribe or advise for the same, by any means or instrumentality."
- 5. Wis. Stats. § 448.03 (1) (a) states that "No person may practice medicine and surgery, or attempt to do so or make a representation as authorized to do so, with a license to practice medicine and surgery granted by the [Medical Examining] board."
- 6. Wis. Stats. § 450.01 (16) (b) provides that "Compounding, packaging, labeling, dispensing and the coincident distribution of drugs and devices" constitutes the practice of pharmacy.
- 7. Wis. Stats. § 450.03 (1) states that "No person may engage in the practice of pharmacy or use the title 'pharmacist' or

sell, give away or barter drugs unless the person is licensed as a pharmacist by the [Pharmacy Examining] board."

8. Ms. Pollard denies the allegations in this matter, but agrees there is evidence from which the Department could make the Findings of Fact, Conclusions of Law and Order set out in the attached Final Decision and Order. She understands that she needs a license to practice either medicine or pharmacy in Wisconsin. In resolution of this matter, she consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Department of Regulation and Licensing has jurisdiction in this matter pursuant to § 440.21, Stats.
- 2. Wis. Stats. § 448.03 (1) (a) requires a license to practice medicine and surgery in Wisconsin.
- 3. Wis. Stats. § 450.03 (1) requires a license to practice pharmacy in Wisconsin.
- 4. By dispensing Arthotec to her clients, Ms. Pollard may have violated Wis. Stats. §§ 448.03 (1) (a) and 450.03 (1).

ORDER

NOW, THEREFORE, IT IS ORDERED that Heather Murphy Pollard is ENJOINED and PROHIBITED as follows:

- 1. SHE SHALL NOT PRACTICE OR OFFER TO PRACTICE MEDICINE AND PHARMACY in Wisconsin unless and UNTIL he obtains a license from the Medical Examining Board, the Pharmacy Examining Board, or both.
- 2. Violation of the order in paragraph 1 above may result in a forfeiture of up to \$10,000 for each offense. Each day a violation continues is considered a separate offense.
- 3. This Order shall become effective on the date of its signing.
