The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Gloria Dowell**, date of birth, 03/17/46, located at 517 Birch Street, in Onalaska, Wisconsin is duly licensed as a barbering and cosmetology manager having license #81 0017754. This license was first granted to her on 03/09/87 is current through 06/30/05.
2. On or about March 25, 2004, an inspection of **Gloria Dowell's** home located at 517 Birch Street, in Onalaska, Wisconsin was performed by an investigator from the Department of Regulation and Licensing. The inspection revealed that there was a sign in the front yard that read "Gloria's Hair Salon." The inspection also revealed that a salon containing barbering and cosmetology equipment was set up in the lower level of the home.
3. According to the Department of Regulation and Licensing records, Gloria's Hair Salon does not have an establishment license.
4. In resolution of this matter, **Gloria Dowell** consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.

2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondent **Gloria Dowell** has violated:

a. Wisconsin Statutes sections 454.15 (2)(i) and 454.08 (1)(a) and Administrative Code section BC 2.045 (1), by providing barbering and cosmetology services outside of a licensed establishment to persons who do not meet exceptions as set forth within the Code.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Gloria Dowell** shall pay to the Department of Regulation and Licensing a forfeiture of **ONE THOUSAND DOLLARS (\$1,000.00)**.

IT IS FURTHER ORDERED, that Respondent **Gloria Dowell**, pay partial costs in this matter in the amount of **TWO HUNDRED DOLLARS (\$200.00)**.

IT IS FURTHER ORDERED, that a down payment of **ONE HUNDRED DOLLARS (\$100.00)** shall be submitted within thirty (30) days from the date of this order and payments of **ONE HUNDRED DOLLARS (\$100.00)** will be due on the first of every consecutive month there after until the full **ONE THOUSAND TWO HUNDRED DOLLARS (\$1,200.00)** is paid. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event **Gloria Dowell** fails to comply with all of the orders set forth above, **Gloria Dowell's** Manager's License # 081 0017754, **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs and forfeiture has been paid to the Department of Regulation and Licensing and her failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 02 BAC 121 be, and hereby is, closed as to the Respondent.
