PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Terrance M. Scheid, M.D. (DOB 05/31/49) is duly licensed to practice medicine and surgery in the state of Wisconsin (license #20-33838) This license was first granted on October 21, 1992. Dr. Scheid's specialty is obstetrics and gynecology.
- 2. Dr. Scheid's most recent address on file with the Wisconsin Medical Examining Board is 619 Samuel Drive, Madison, WI 53717.
- 3. On July 12, 2003, the Minnesota Board of Medical Practice issued an order that conditioned and restricted the license of Dr. Scheid to practice medicine in Minnesota. This action was based on several instances of excessive blood loss experienced by Respondent's patients during and/or after gynecologic laparoscopic surgical procedures. A true and correct copy of the Stipulation and Order is attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.
- 4. In resolution of this matter, Dr. Scheid consents to the entry of the following Conclusions of Law and Order as a reasonable accommodation, based upon the facts and circumstances of this case.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to sec. 448.02(3), Stats. and is authorized to enter into the attached Stipulation and Order, pursuant to sec. 227.44(5), Stats.
- 2. The conduct described in paragraph 3, above, constitutes a basis for the imposition of discipline pursuant to Wis. Admin. Code § Med 10.02(q).

ORDER

NOW, THEREFORE, IT IS HEREBY <u>ORDERED</u> that the Wisconsin license of Terrance M. Scheid, M.D. (license #20-33838) is REPRIMANDED.

IT IS FURTHER ORDERED that Respondent's Wisconsin license is LIMITED as follows:

- 1. Respondent shall maintain full and complete compliance with all terms, limitations, and conditions imposed against his medical license in the State of Minnesota.
- 2.. Within 30 days of the date of this Order, Respondent shall provide proof satisfactory to the Board that he has arranged with the Minnesota medical licensing board for immediate submission of notification to the Department Monitor of any violation by Respondent of the Minnesota Order.
- 3. Respondent, himself, agrees to submit notification to the Department Monitor of any violation by Respondent of the Minnesota Order.
- 4. Respondent shall provide the Board with current releases, complying with state and federal laws, authorizing release and access to his records with the Minnesota Board.
- 5. All reports and petitions made pursuant to this Order shall be sent to the Department Monitor of the Wisconsin Department of Regulation and Licensing at the address set forth below.

6. Respondent shall immediately surrender all indicia of Wisconsin registration to the Department Monitor. The Department shall reissue registration credentials to Respondent marked "limited."

IT IS FURTHER ORDERED that

- 7.. Prior to resumption of the practice of medicine in the state of Wisconsin [or elsewhere under the use of his Wisconsin license] Respondent shall notify the Board Monitor of his desire to resume the active use of his Wisconsin licensure and petition the Board for permission to practice within this state.
 - a. In conjunction with a petition by Respondent, the Board shall require current documentation of the status of Respondent's compliance with the terms and conditions imposed against his Minnesota license to practice medicine.
 - b. In the exercise of its discretion, the Board may in addition require a personal appearance by Respondent to answer questions in conjunction with his petition.

- c. Upon its completion of review of a petition under this Order, the Board may grant Respondent permission to practice medicine in this state, subject to such terms and conditions as the Board in the exercise of its discretion finds appropriate to safeguard the public health, safety and welfare.
- d. Respondent may petition the Board for removal or revision of any of the terms and conditions imposed pursuant to this Order at any time.

IT IS FURTHER ORDERED that

- 8. Within ninety (90) days from the date of this Order, Respondent shall pay to the Department of Regulation and Licensing COSTS of the investigation and prosecution of this action in the sum of \$200. Payment shall be made by certified check or money order, made payable to the Wisconsin Department of Regulation and Licensing and submitted to the Department Monitor.
- 9. Denial in whole or in part of a petition under this Order shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§ 227.01(3) and 227.42.
- 10. Violation of any of the terms of this Order or the conditions imposed as a result of this Order shall be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license; the Board in its discretion may in the alternative deny an extension of the stay of suspension or impose additional conditions and limitations other additional discipline for a violation of any of the terms of this Order.
 - 11. This Order shall become effective on the date of its signing.
