The parties in this matter, Ivan Teoh, M.D., Respondent, personally and by his attorney, John F. Mayer, Nash, Grimstad, Spindler and McCracken LLP, and Pamela M. Stach, Attorney for the Department of Regulation and Licensing, Division of Enforcement, agreed to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed the Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached stipulation and makes the following:

FINDINGS OF FACT

1. Ivan Teoh, M.D., Respondent herein, of 19943 Sky Hollow Lane, Katy, Texas 77450, whose date of birth is December 17, 1944, is licensed and currently registered to practice medicine and surgery in the State of Wisconsin under license number 20213 which was granted on July 22, 1976.
2. There is a formal investigation of Respondent pending before the Wisconsin Medical Examining Board which involves investigative file 01 MED 191.
3. The investigation involves allegations of failure to perform adequate postoperative assessments and failure to provide necessary treatment for complications following inadvertent intestinal perforation which occurred during a laparoscopic cholecystectomy.
4. Respondent retired from the practice of medicine in 2002 and is currently residing in the State of Texas.
5. Respondent does not hold a license to practice medicine in any jurisdiction other than Wisconsin.
6. Respondent has cooperated during the course of the investigation.
7. Respondent agrees that he will not practice medicine and surgery in the State of Wisconsin after the effective date of this Order and will not renew his registration to practice medicine and surgery in the State of Wisconsin in the future except

as set forth in this Order.

### CONCLUSIONS OF LAW

1. The Medical Examining Board has jurisdiction in this proceeding pursuant to sec. 448.03 Wis. Stats.
2. The Medical Examining Board has the authority to resolve this matter by stipulation without an evidentiary hearing pursuant to Wis. Stats. sec. 227.44(5).

### ORDER

NOW THEREFORE IT IS ORDERED that the Stipulation of the parties is hereby accepted.

IT IS FURTHER ORDERED that Ivan Teoh, M.D. shall not engage in the practice of medicine and surgery in the State of Wisconsin under his current registration after the effective date of this Order and shall not renew his registration to practice medicine and surgery in the State of Wisconsin at any time in the future.

IT IS FURTHER ORDERED that Ivan Teoh, M.D. shall not practice or attempt to practice medicine or surgery in the State of Wisconsin when not licensed and currently registered.

IT IS FURTHER ORDERED that in the event Ivan Teoh, M.D. wishes to resume the practice of medicine and surgery in the State of Wisconsin at some future date, he shall have the right to appear before the Medical Examining Board to request the opportunity to reregister to practice and, if necessary, reapply for licensure and to satisfy the Board as to his competence to resume practice. Evidence of such competence may include, but not be limited to, any testing, evaluation, assessment or retraining the Board deems appropriate. The Board shall review the allegations and evidence contained in the investigative file which is the basis of this investigation and the results of the pending malpractice case entitled Thomas F. O'Conner Sr., et. al. v. Ivan Teoh, M.D. et. al., Ashland County 03 CV 41. In particular, the Board shall consider any determination of negligence on the part of Respondent. The Board shall consider the above information, if available, prior to determining whether to allow Ivan Teoh, M.D., to resume the practice of medicine and surgery and, if so, under what conditions. The Board shall not unreasonably deny Respondent's request to resume practice.

IT IS FURTHER ORDERED that investigative files 01 Med 191 is hereby closed without further proceedings.

IT IS FURTHER ORDERED that this Order is effective upon signing.
