The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Real Estate Board ("Board"). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. **Peter M. Skanavis** ("Skanavis"), date of birth 08/27/56, is licensed in the State of Wisconsin as a real estate broker having license # 90-33558. This license was first granted to him on 01/10/85. Skanavis' most recent address on file with the Department of Regulation and Licensing is 6768 Maple Terrace, Wauwatosa, WI 53213.
- 2. Skanavis is the broker and business representative for Metrostar Inc. d/b/a Homeowners Concept which holds license # 91- 833152 as a real estate business entity. This license was first granted to it on 01/15/85.
- 3. On or about September 11, 2003, an auditor with the Department of Regulation and Licensing conducted an audit of Metrostar's real estate trust account and bookkeeping records. During the audit the auditor discovered discrepancies in the real estate trust account as follows:

The ledger was not adequately maintained;
Trial balances were not performed;
Validations not performed; and
A balance of \$653.00 in the real estate trust account.

Form 344 completed by the auditor and signed by Skanavis is attached as **Exhibit 1** and is hereby incorporated into this document.

CONCLUSIONS OF LAW

- 1. The Wisconsin Real Estate Board has jurisdiction to act in this matter pursuant to sec. 452.14, Wis. Stats.
- 2. The Wisconsin Real Estate Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
 - 3. Respondent **Peter M. Skanavis** has violated:
 - a Section 452.14(3)(i) of the Wisconsin Statutes by demonstrating incompetency to act as broker in a manner which safeguards the public by failing to maintain a required ledger and by failing to do the required monthly trial balances and validations, by commingling funds and by failing to maintain a sum of not more than \$300.00 in the real estate trust account.
 - 4. Respondent **Metrostar Inc.** has violated:
 - a Sections RL 18.13(2), RL 18.13(4), and RL 18.13(5) of the Wisconsin Administrative Code by failing to maintain a required ledger and by failing to do the required monthly trial balances and validations.
 - b. Section RL 18.10 of the Wisconsin Administrative Code by commingling funds and by failing to maintain a sum of not more than \$300.00 in the real estate trust account.

ORDER

NOW THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED that Respondent **Peter M. Skanavis**, license #90-33558, be, and hereby is, **REPRIMANDED**.

IT IS FURTHER ORDERED that Respondent **Peter M. Skanavis**, within six months of the date of this Order, successfully complete the following course modules from the 36 hour pre-licensing real estate broker's course at an educational institution approved by the Department of Regulation and Licensing:

- a. The Trust Accounts, Escrow, Closing Statement module-section RL§ 25.02(2)(c), Wisconsin Administration Code.
 - b. The Financial and Office Management module-section RL §25.02(2)(e), Wisconsin Administration Code.

and submit proof of same to the Real Estate Board, P.O. Box 8935, Madison, WI 53708-8935, in the form of verification from the institution providing the education. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that are or may be instituted by the Board or the Department of Regulation and Licensing.

IT IS FURTHER ORDERED that in the event Respondent **Peter M. Skanavis** fails to successfully complete the educational requirements within the time and in the manner as set forth above, then and in that event, and without further notice to the Respondent **Peter M. Skanavis** his real estate license shall be suspended without further hearing and without further Order of the Board, and said suspension shall continue until further Order of the Board.

IT IS FURTHER ORDERED that Respondent **Peter M. Skanavis** pay a **FORFEITURE of \$350.00** within 30 days of the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing, and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED that in the event Respondent **Peter M. Skanavis** fails to pay the \$350.00 forfeiture within the time and in the manner as set forth above, then and in that event, and without further notice to the Respondent **Peter M. Skanavis**, his real estate license shall be suspended without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said forfeiture has been paid to the Department of Regulation and Licensing. His failure to pay the forfeiture shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED that Respondent **Peter M. Skanavis** pay partial **COSTS** of this matter in the amount of \$300.00 within 30 days of the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing, and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED that in the event Respondent **Peter M. Skanavis** fails to pay the \$300.00 in costs within the time and in the manner as set forth above, then and in that event, and without further notice to the Respondent **Peter M. Skanavis**, his real estate license shall be suspended without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs have been paid to the Department of Regulation and Licensing. His failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED that Respondent Metrostar Inc., license #91-833152, is hereby REPRIMANDED.

IT IS FURTHER ORDERED, that file 03 REB 196 be, and hereby is, closed.
