The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Ravin Manes & Co.**, located at 126 Graham Avenue, in Eau Claire Wisconsin is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license # 080 0029479. This license was first granted to the establishment on 11/24/00 and is current through 6/30/05.
2. **Susan K. Paulson**, date of birth 11/03/47, located at 126 Graham Avenue in Eau Claire, Wisconsin is the listed owner of **Ravin Manes & Co.** and is duly licensed in the State of Wisconsin as a Barbering or Cosmetology Manager, having license # 81 0027011. This license was first granted to her on 10/20/97 and is current through 6/30/05.
3. As owner, **Susan K. Paulson** was and is at all times relevant to this action responsible for compliance with Wisconsin Statute, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapter 2.
4. On or about May 15, 2002, an inspection of **Ravin Manes & Co.** was performed by an investigator from the Department of Regulation and Licensing. During the inspection the investigator found that the establishment complied with all sanitation requirements.
5. On or about June 27, 2002, an investigator contacted **Susan K. Paulson** and discussed the situation concerning Clayton Crowley performing barbering and cosmetology services without a current license. **Susan K. Paulson** admitted that Clayton Crowley had leased space from her and had been performing barbering and cosmetology services at **Ravin Manes & Co.** **Susan K. Paulson** stated that she asked Clayton Crowley about the status of his license and he

falsely told her that he had a current license. **Susan K. Paulson** also stated that once she found out that Clayton Crowley did not have a license, she immediately informed him that he could no longer provide barbering and cosmetology services at **Ravin Manes & Co.**

6. In resolution of this matter, **Susan K. Paulson D/B/A Ravin Manes & Co.** consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.

2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondents **Susan K. Paulson D/B/A Ravin Manes & Co.** has violated:

a. Wisconsin Administrative Code section BC 2.04 (1) by permitting unlicensed activity in her establishment.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Susan K. Paulson** shall pay to the Department of Regulation and Licensing a forfeiture of **SEVEN HUNDRED AND FIFTY DOLLARS (\$750.00)**.

IT IS FURTHER ORDERED, that Respondent **Susan K. Paulson**, pay costs in this matter in the amount of **TWO HUNDRED FIFTY DOLLARS (\$250.00)**.

IT IS FURTHER ORDERED, that a down payment of **TWO HUNDRED FIFTY DOLLARS (\$250.00)** shall be submitted within thirty (30) days from the date of this order and payments of **TWO HUNDRED FIFTY DOLLARS (\$250.00)** will be due on the first of every consecutive month there after until the full **ONE THOUSAND DOLLARS (\$1,000.00)** is paid. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935.**

IT IS FURTHER ORDERED, that in the event **Susan K. Paulson** fails to timely submit payment of the forfeiture and costs as set forth above, her Manager License # 081 0027011 **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs have been paid to the Department of Regulation and Licensing and his failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 02 BAC 037 be, and hereby is, closed as to **Susan K. Paulson D/B/A/ Ravin Manes & Co.**
