The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Suzanne M. Feige (Date of Birth: June 23, 1949) 2619 South Logan Avenue, Milwaukee, WI 53207, is duly licensed as a barbering or cosmetology manager in the state of Wisconsin (license #81-13866). This license was first granted on December 23, 1976, and is current through June 30, 2005.
- 2. Bay View Beauty Shop, 2631 South Kinnickinnic Avenue, Milwaukee, WI 53207, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #80-12234). This license was first granted on July 9, 1976 and is current through June 30, 2005. Suzanne M. Feige is listed with the Department of Regulation and Licensing as the owner and manager of Bay View Beauty Shop. As owner-manger of a licensed barbering and cosmetology establishment, Ms. Feige was responsible for compliance with Ch. 454, Stats., and Wisconsin Administrative Code Chs. BC 2, 3 and 4.
- 3. An inspection of Bay View Beauty Shop by an Investigator of the Department of Regulation and Licensing on December 11, 2003, revealed that the Hydrocide was not changed daily, that curlers were heavily contaminated with hair, and that the storage areas for the curlers were contaminated with hair. Poisonous substances were also stored in a public area in a non-locked area.

4. In resolution of this matter, Suzanne M. Feige d/b/a Bay View Beauty Shop consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3 above, Suzanne M. Feige d/b/a Bay View Beauty Shop violated:

Sec. 454.15(2)(i), Stats. Violated this chapter or any rule promulgated under this chapter.

Wis. Admin. Code § 3.01(6). Establishments shall provide safe and secure areas for storing, cleaning and disinfecting equipment. Poisonous substances stored in public areas shall be locked in a cabinet or closet.

Wis. Admin Code § BC 4.01(1). All areas of the establishment and the equipment, tools and implements used by licensees for services in an establishment shall be maintained in a clean, sanitary and safe condition.

Wis. Admin. Code § BC 4.01(7). All other equipment and instruments shall be clean to sight and touch.

Wis. Admin. Code § BC 4.02(1). Unless sterilized, disinfection is required prior to reuse on another patron of any personal care instruments, including scissors, razors, clipper blades and tweezers.

Wis. Admin. Code § BC 4.02(3). Disinfection for combs, lifts, brushes, rollers and any other contact equipment shall consist of cleaning with soap and water to remove all organic material, spraying with a tuberculocidal disinfectant as defined in s. BC 1.01, and air drying.

Wis. Admin. Code § BC 4.02(4). Clean and disinfected contact equipment shall be placed in one or more covered containers. One or more separate containers shall be provided for immediate storage of soiled contact equipment until cleaned and disinfected.

Wis. Admin. Code § BC 4.02(5). Disinfectant used for decontamination shall be changed daily and shall be kept in a covered container.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Suzanne M. Feige d/b/a Bay View Beauty Shop, shall pay to the Department of Regulation and Licensing a forfeiture of THREE HUNDRED dollars (\$300.00), plus partial costs of TWO HUNDRED dollars (\$200.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Respondents fail to timely submit any payment of the forfeiture as set forth above, the establishment license of Bay View Beauty Shop (#80-12234) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
