The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. **Cyndi's Electrolysis** is located at 1566 W Mason St., Green Bay, WI, and is duly licensed as an electrology establishment in the State of Wisconsin having license # 70 256. This license was first granted to the establishment on 12/17/87 and is current through 06/30/05.
- 2. On or about May 14, 2004, an inspection of **Cyndi's Electrolysis** was performed by an investigator from the Department of Regulation and Licensing. During the inspection the investigator found poisonous substances were not being stored in a locked cabinet or closet.
- 3. In resolution of this matter, **Cyndi's Electrolysis** consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

- 3. Respondent **Cyndi's Electrolysis** has violated:
 - a. Wisconsin Administrative Code section BC 3.01 (6) by not storing poisonous substances in a locked cabinet or closet.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent Cyndi's Electrolysis shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED DOLLARS (\$100.00).

IT IS FURTHER ORDERED, that Respondent Cyndi's Electrolysis, pay costs in this matter in the amount of FOUR HUNDRED DOLLARS (\$400.00).

IT IS FURTHER ORDERED, that a payment of **FIVE HUNDRED DOLLARS** (\$500.00) shall be submitted within thirty (30) days from the date of this order. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event **Cyndi's Electrolysis** fails to timely submit payment of the forfeiture and costs as set forth above, the electrology establishment License # 70 256 **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount has been paid to the Department of Regulation and Licensing and its failure to pay the full amount shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 03 BAC 083 be, and hereby is, closed.
