1. The Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors – Landscape Architect Section has jurisdiction to act in this matter pursuant to Wis. Stats. § 443.11.

2. The Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors – Landscape Architect Section is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondent ROBERT B. DOWNING has violated: Wis. Stats. § 443.11(1)(d), misconduct as evidenced by using the title of “Landscape Architect” while his license was not current and valid.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **ROBERT B. DOWNING**, license # 14-341, be, and hereby is, **REPRIMANDED**.

IT IS FURTHER ORDERED, that Respondent **ROBERT B. DOWNING** pay **costs** of this matter in the amount of \$250.00, within 30 days of the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935**.

IT IS FURTHER ORDERED, that Respondent **ROBERT B. DOWNING** shall pay licensing fees, including late penalties, for the period of time during which Downing continued to use the title of Landscape Architect while not possessing a valid license, which is determined to be \$157.00, including applicable late fees, within 30 days of the date of this Order. Said amount shall be sent to **Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935**, in the form of a **separate payment**, accompanied by a letter indicating that this amount is for licensing fees due and owed.

IT IS FURTHER ORDERED, that in the event Respondent **ROBERT B. DOWNING** fails to pay the \$250.00 **costs** or \$157.00 **licensing fees** within the time and manner as set forth above, then and in that event, and without further notice to the Respondent **ROBERT B. DOWNING**, his Landscape Architect’s license shall be suspended without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs have been paid to the Department of Regulation and Licensing and his failure to pay the costs shall be considered a violation of this Order by the Board.
