The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Amy L. Chamberlain, f/k/a Amy L. Krahn (D.O.B. 7/6/78) is duly licensed in the state of Wisconsin as a practical nurse (license # 303516). This license was first granted on 12/21/01.
2. On 6/9/03, respondent was found guilty of possession of marijuana, a Schedule I controlled substance, contrary to county ordinance, in the Circuit Court for Monroe County, Wisconsin; the offense occurred on 3/12/03. She was assessed costs of \$91, and no other penalty.
3. The Board has reviewed respondent's relevant health care records, and has no evidence that respondent is dependent upon any mood-altering substance.

CONCLUSIONS OF LAW

By the conduct described above, respondent is subject to disciplinary action against her license to practice as a registered nurse in the state of Wisconsin, pursuant to Wis. Stats. §441.07(1)(b) and (d), and Wis. Adm. Code §§ N 7.04(1) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the attached stipulation is ACCEPTED.

IT IS FURTHER ORDERED: that Amy L. Krahn, LPN, is REPRIMANDED for her unprofessional conduct in this matter.

IT IS FURTHER ORDERED that respondent shall pay the costs of investigating and prosecuting this matter, in the amount of \$450, within 90 days of this Order.
