FINAL DECISION AND ORDER

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. James A. Hefter, R.N., Respondent, date of birth August 18, 1948, is licensed by the Wisconsin Board of Nursing as a registered nurse in the state of Wisconsin pursuant to license number 69914, which was first granted March 30, 1978.
- 2. Respondent's last address reported to the Department of Regulation and Licensing is 580 Lake Street, Fond du Lac, WI 54937.
- 3. Respondent was convicted of Operating While Intoxicated (OWI) on October 20, 1999 and again on December 5, 2000. Following his second OWI conviction on December 5, 2000, Respondent's driver's license was revoked for 12 months and he was sentenced to 5 days in jail.
- 4. Respondent was employed as a registered nurse on the acute psychiatric inpatient unit at the Fond du Lac County Department of Community Programs (FDL Co) in Fond du Lac, Wisconsin:
 - a. On August 4, 2001, Respondent reported for his scheduled shift at 7:15 p.m. while under the influence of alcohol to an extent that his ability to safely and reliably practice was impaired.
 - b. The results of a blood test taken at that time showed Respondent's blood alcohol level to be .15%.
- 5. On August 15, 2001, Respondent completed an AODA assessment at Associated Counseling & Recovery Center in Fond du Lac, which resulted in a diagnosis of alcohol dependence with a recommendation for therapy.

- 6. On January 17, 2002, Respondent completed an application for participation in the Department of Regulation and Licensing Impaired Professionals Procedure (IPP), a non-disciplinary monitoring program that may be offered to credential holders with alcohol and/or drug issues, which allows participants to obtain treatment and ongoing aftercare while returning to safe practice.
- 7. On May 1, 2002, Respondent signed an "Agreement for Participation" in IPP, consenting to abide by various conditions set out in the contract, which included:
 - a. The conditions related to rehabilitation, monitoring, treatment and practice.
 - b. Respondent agreed to submit to random, monitored alcohol and drug screens on the basis of not more than 60 time(s) per year.
 - c. Respondent agreed to be abstinent of alcohol, controlled substances and prescription drugs not prescribed for a valid medical purpose.
 - d. Respondent agreed to have his physician provide a written report to IPP within 3 days of prescribing any medication for a valid medical purpose.
- 8. While in IPP, Respondent provided random urine screens, some of which tested positive for benzodiazepines and ethanol. On April 7, 2003, the IPP Coordinator wrote to Respondent and asked him to provide an explanation for the positive screens and why he believed he should remain in IPP.
- 9. Respondent submitted an explanation which the IPP Advisor did not find convincing. On May 13, 2003, the IPP Coordinator informed Respondent that any further positive screens not specifically supported by a prescription, or other noncompliance, would seriously threaten his continuation in IPP.
- 10. Urine screens provided on May 2 and July 8, 2002 tested positive for lorazepam, a controlled substance. No supporting information was sent by Respondent's physician.
- 11. On August 11, 2003, the IPP Coordinator informed Respondent that the Board had dismissed him from IPP based on substantial violations of his "Agreement for Participation."
- 12. On May 7, 2003, prior to his dismissal from IPP, Respondent was arrested for a third OWI. Respondent was convicted of that charge on September 29, 2003 and as a result, his driver's license was revoked for 32 months and he was sentenced to 75 days in jail.
 - 13. On August 24, 2004, Respondent was scheduled to work the 11:15 p.m.–7:15 a.m. shift at FDL Co:
 - a. Respondent arrived late for his shift, smelling of alcohol and behaving strangely.
 - b. Because of his condition, Respondent was unable to provide necessary nursing services to a patient who was going through alcohol withdrawal.
 - c. A physician who was present reported that Respondent was intoxicated.
 - d. Respondent agreed to a blood test which was requested by a supervisor and the results showed his blood alcohol level to be .17%.
 - e. Respondent was under the influence of alcohol to an extent that his ability to safely and reliably practice was impaired.
 - f. As a result of these events, Respondent was terminated from his employment at FDL Co.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction over this matter pursuant to Wis. Stats. § 441.07 and has authority to enter into this stipulated resolution of this matter pursuant to Wis. Stats. § 227.44(5).
- 2. Respondent, by engaging in the conduct set out above, has abused alcohol to an extent that such use impairs his ability to safely or reliably practice, as defined by Wis. Adm. Code § N 7.03(2), which subjects Respondent to discipline pursuant to Wis. Stats. § 441.07(1)(c).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED:

- 1. The SURRENDER by James A. Hefter R.N., Respondent, of his license as a registered nurse in the state of Wisconsin is hereby ACCEPTED, effective immediately.
- 2. Respondent shall, within 90 days of the date of this Order, pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$385.00 pursuant to Wis. Stats. § 440.22(2).
