The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. David Sommerfeld, D.C. (D.O.B. 07/09/1956) is duly licensed as a chiropractor in the state of Wisconsin (license #1595). This license was first granted on July 30, 1980.
- 2. Dr. Sommerfeld's most recent address on file with the Wisconsin Chiropractic Examining Board is 6 W. Saint Patrick Street, Rice Lake, WI 54868.
- 3. The Department has received a complaint regarding the care of patient AF. On or about May 20, 1999, patient AF went to Dr. Sommerfeld's office for an initial visit. Dr. Sommerfeld indicates that he performed an extensive physical examination of patient AF. However, there is no record of that examination in Dr. Sommerfeld's notes.
 - 4. In resolution of this matter, Dr. Sommerfeld consents to entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct described above, Dr. Sommerfeld is subject to disciplinary action against his license to practice as a chiropractor in the state of Wisconsin, pursuant to sec 446.03(5), Stats. and Wisconsin Administrative Code § Chir 6.02.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that David Sommerfeld, D.C. is REPRIMANDED.

IT IS FURTHER ORDERED that within six months of this order, Respondent shall present documentation acceptable to the Board that he has completed an acceptable continuing education course in recordkeeping.

This Order shall become effective upon the date of its signing.
