Madison, W1 53708-8935 The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Secretary of the Department of Regulation and Licensing. The Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing adopts the attached Spipulation and makes the following:

- 2. DBP Detertive & Security Agency (Agency), is licensed in the State of Wisconsin as a Private Detective Agency having license #6.2-15914. This license was first granted to it on 09/22/98 and is current through August 31, 2006. DBP Detective & Security Agency's most recent address is PO Box 510644, Milwaukee, WI 53203.
- 3. On or about April 9, 2002, the Department of Regulation and Licensing (Department) requested that the Respondent forward to the Department a list of the employees of the Agency from June 1, 2001, through the current date.
- 4. The employee list that the Respondent supplied the Department was verified and it was revealed that out of twenty five employees, fifteen employees either worked as a private security guard prior to obtaining a per
- 5. The Respondent alleges that an employee of the Agency was responsible for completing the necessary documents and for maintaining accurate records for the individual licensees
- When the Respondent became aware that the employee was not completing the necessary documents and maintaining accurate records, the Respondent fired the employee
- 8. The employee list that was supplied to the Department by office staff was verified and it was revealed that out of eighteen employees, two employees that were actively practicing as a private security guard had never obtained a permit.
- 9. On or about September 10, 2003, the employee who forwarded the employee list to the Department, and was responsible for completing the necessary documents and maintaining accurate records was also let go by the Respondent.
- 1. The Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(8), and is authorized to enter into the attached Stipulation pu
- 2. The conduct described above in paragraphs #4 and 8, above, constitutes a violation of:
  - a. Wisconsin Administrative Code 8 RL 35.01(13) by assigning persons to perform private security duties who were not licensed.
  - b. Wisconsin Administrative Code §§ R.L. 33.03, and R.L. 33.04 by failing to furnish private security personnel with identification tags and agency photo ide

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. DBP Detective & Security Agency and Dino Baschiera, license #62-15914 and license # 63-9919 be, and hereby are, REPRIMANDED.
- 2. The Respondents shall within sixty (60) days of the date of this Order jointly and severally, pay partial costs of this proceeding in the amount of \$1,000.00. Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to

In the event the Respondents fail to timely submit payment of costs as ordered the Respondent's licenses (862-15914 and license # 63-9919) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has paid the cost ordered.
