The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. **Artistic Styles**, located at 3070 N. 79th Street, in Milwaukee, Wisconsin is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license # 080 0029487. This license was first granted to the establishment on 03/29/99 and is current through 06/30/05.
- 2. **Darshel R. Harris**, date of birth 05/25/71, located at 3070 N. 79th Street, in Milwaukee, Wisconsin is the listed owner of **Artistic Styles**. According to the Department of Regulation and Licensing Records, **Darshel R. Harris** has a current apprentice license, #600 006486. This license was first granted to her on 08/12/94 and is current through 03/31/05.
- 3. As owner, **Darshel R. Harris** was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters 2 and 3.
- 4. On or about July 29, 2004, an inspection of **Artistic Styles** was performed by two investigators from the Department of Regulation and Licensing. The inspection revealed that Fred Andrews, Jouta Cross, and Larry Dupree were providing barbering and cosmetology services without valid licenses. The inspection also revealed that **Artistic Styles** had been operating without a manager since June 18, 2003. The inspection also revealed that **Artistic Styles** establishment license had remained in expired status from July 9, 2001 until March 18, 2003.
- 6. According to the Department of Regulation and Licensing records, the status of **Artistic Styles** establishment license was changed from expired to active on 03/18/03 and is current through 06/30/05.
 - 7. Department of Regulation and Licensing records indicate that as of August 2, 2004, Artistic Styles is

employing a licensed manager.

8. In resolution of this matter, **Darshel R. Harris and Artistic Styles** consent to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stats. Sec. 454.15,
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stats.sec. 227.44(5),
 - 3. Respondents **Darshel R. Harris and Artistic Styles**, has violated:
 - a. Wisconsin Statutes sections 454.15(2)(i) and 454.08(1)(b) by failing to maintain a current establishment license
 - b. Wisconsin Statutes section 454.04 (1)(a) and Wisconsin Administrative Code sections BC 2.04 (1) and 2.06 (4) by permitting others to engage in the unlicensed practice of barbering and cosmetology.
 - c. Wisconsin Statutes section 454.10(3) and Wisconsin Administrative Code section 6.04(1) by permitting an apprentice to practice barbering and cosmetology without the supervision of a licensed manager from the dates of June 18, 2003 to August 1, 2004.
 - d. Wisconsin Administrative Code section BC 3.02 (1) and Wisconsin Administrative Code section 2.06 (5) by failing to employ a licensed manager from the period of June 18, 2003 to August 1, 2004.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondents shall pay to the Department of Regulation and Licensing a forfeiture of **FOUR THOUSAND DOLLARS (\$4,000.00)**.

IT IS FURTHER ORDERED, that Respondents, pay costs in this matter in the amount of **TWO THOUSAND DOLLARS (\$2,000.00).**

IT IS FURTHER ORDERED, that a down payment of **TWO HUNDRED DOLLARS** (\$200.00) shall be submitted thirty (30) days from the date of this order and four payments of **ONE THOUSAND FOUR HUNDRED FIFTY DOLLAI** (\$1,450.00) will be due every three months until the full **SIX THOUSAND DOLLARS** is paid. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Departmen Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-89**.

IT IS FURTHER ORDERED, that in the event **Darshel R. Harris** and **Artistic Styles** fail to timely submit payment of the forfeiture and partial costs as set forth above, **Darshel R. Harris's** Apprentice Permit # 600 006486 and **Artistic Styles** Barbering and Cosmetology Establishment License # 080 0029487 **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs have been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 03 BAC 077 and 04 BAC 046 be, and hereby is, closed as to **Darshel R. Harris and Artistic Styles**.
