A meeting of the State of Wisconsin Pharmacy Examining Board was held on August 11, 2004, during which the board reviewed a petition by Robert V. Guzzetta for the granting of a three month stay of suspension as provided by a *Final Decision and Order* (“*Order*”) dated September 13, 1994. (94 PHM 77). Also requested by Guzzetta was that drug screen testing for pemoline be eliminated. The drug screen modification request was supported by his therapist.

Based upon the board’s review of the petition and the supporting documentation presented;

IT IS HEREBY ORDERED: that Robert V. Guzzetta, is granted a three-month stay of the suspension of license #10594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request the request to eliminate screening for pemoline, is granted, with the condition that Guzzetta continue to practice at a nuclear pharmacy.
