A meeting of the State of Wisconsin Pharmacy Examining Board was held on January 14, 2004, during which the board reviewed a petition by Robert V. Guzzetta for the granting of a three month stay of suspension as provided by a *Final Decision and Order* (“*Order*”) dated September 13, 1994. (94 PHM 77).

Based upon the board’s review of the petition and the supporting documentation presented;

IT IS HEREBY ORDERED: that Robert V. Guzzetta, is granted a three-month stay of the suspension of license #10594 to practice pharmacy in the State of Wisconsin.

NOTE- Paragraph 2c(2) of the *Order* prohibits employment as a managing pharmacist at a Wisconsin licensed pharmacy.
