On August 19, 2004, the Board of Nursing reconsidered the petitioner's request for a further three month stay of the suspension, in light of additional information received concerning a possible violation for positive drug screen. Based upon all information of record herein, the Board reconsidered the prior motion on July 29, 2004, denying stay and now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that a stay of the suspension of the RN license of RANDALL N. PROCKNOW, is hereby GRANTED for a further period of three months.

IT IS FURTHER ORDERED that the petitioner may continue to use the Theda Care Laboratories for his drug screens, provided that the laboratory provides his test results directly to the Department Monitor.

This Order is effective upon the date of signing and is continuous from the date of the expiration of the previous stay.
