On August 11, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by John R. Schmitt, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order*, (“*Order*”) dated August 13, 1997. Schmitt also petitioned to be allowed to work one day per week unsupervised as a pharmacist in charge. Paragraph 2.c.(3) of the *Order* provides in part: *Any such petition shall be accompanied by written request of the supervising pharmacist, which shall include a complete work schedule of all pharmacists employed in the pharmacy indicating the proposed work schedule and supervision pattern for respondent.* The required documentation required by paragraph 2.c.(3) has not been submitted.

Based upon the board's review of the documentation submitted,

IT IS HEREBY ORDERED: that John R. Schmitt, R.Ph., is granted a three-month stay of the suspension of license #8852 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the petition to work unsupervised as a pharmacist in charge is DENIED.
