On August 11, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by John R. Schmitt, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order*, ("*Order*") dated August 13, 1997. Schmitt also petitioned to be allowed to work one day per week unsupervised as a pharmacist in charge. Paragraph 2.c.(3) of the *Order* provides in part: *Any such petition shall be accompanied by written request of the supervising pharmacist, which shall include a complete work schedule of all pharmacists employed in the pharmacy indicating the proposed work schedule and supervision pattern for respondent. The required documentation required by paragraph 2.c.(3) has not been submitted.* 

Based upon the board's review of the documentation submitted,

IT IS HEREBY ORDERED: that John R. Schmitt, R.Ph., is granted a three-month stay of the suspension of license #8852 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the petition to work unsupervised as a pharmacist in charge is DENIED.
