On Thursday, September 16, 2004 and pursuant to the Order currently in effect against Mary E. Trahan, the Board of Nursing considered the petitioner's request for a further three month stay of the suspension. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petition of Mary E. Trahan, (license # 92148) for a stay of suspension is GRANTED for a period of three months.

Ms. Trahan's petition for a discontinuance of required drug screens and therapy sessions is DENIED, as too little time has passed since petitioner's last documented relapse (in 2002) to allow for discontinuance of monitoring. All terms, conditions and limitations affecting petitioner's license remain in effect.
