On Thursday, September 16, 2004, the Board of Nursing considered the petitioner's request for a reinstatement of her Wisconsin nursing license. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petition of Shirley A. (Caballero) Jackson, RN (license #91308) for a reinstatement her license to practice as a Registered Nurse in the state of Wisconsin is DENIED. Petitioner has failed to provide evidence of rehabilitation required pursuant to the Board's 07-09-1998 Order against her license. In order to be considered for reinstatement, Ms. Jackson must provide a current evaluation of her condition, proof of continuous satisfactory participation in a treatment program acceptable to the Board, and satisfactory proof that she is capable of safely and reliably performing the functions of a professional nurse. PLEASE NOTE that you have a right to a hearing on the denial of your application for reinstatement if you file a request for hearing in accordance with the provisions of Ch. RL 1 of the Wisconsin Administrative Code. You may request a hearing within 45 calendar days after the mailing of this notice of denial. Your request must be submitted in writing to the Board of Nursing at: Department of Regulation and Licensing, 1400 East Washington Avenue, P.O. Box 8935, Madison, WI 53708-8935.

The request must contain your name and address, the type of credential for which you have applied, a specific description of the mistake in fact or law that you assert was made in the denial of your credential, and a concise statement of the essential facts which you intend to prove at the hearing. You will be notified in writing of the Board of Nursing's decision. Under s. RL 1.08 of the Wisconsin Administrative Code, a request for a hearing is denied if a response to a request for a hearing is not issued within 45 days of its receipt by the Board. Time periods for a petition for review begin to run 45 days after the Board has received a request for a hearing and has not responded.

This Order is effective upon the date of signing.
