At its December 10, 2003, meeting, the board was presented with a petition by James A. Meyer, R.Ph., for a stay of suspension pursuant to the terms of the board's *Final Decision and Order* (“*Order*”) dated November 10, 1998, 98 PHM 34. By previous board order dated November 12, 2002, Meyer’s license was suspended resulting from a violation of the *Order*. On December 10, 2003, the board ordered that James A. Meyer, R.Ph., was denied a three-month stay of the suspension of license #11446 to practice pharmacy in the State of Wisconsin, and that Meyer was to cause to be submitted to the board urine drug screen test results for all tests from August 1, 2003, to the present, for review pending any further consideration of the granting of a stay of suspension. At its January 14, 2004, meeting, the board was again presented with a petition by James A. Meyer, R.Ph., for a stay of suspension pursuant to the terms of the board's *Final Decision and Order* (“*Order*”) dated November 10, 1998, 98 PHM 34. Included with the petition for the board’s review were urine drug screen test results for all tests from August 1, 2003, to the present. Based upon the board’s review of the petition, and the supporting documents therewith:

IT IS HEREBY ORDERED: that James A. Meyer, R.Ph., is granted a three-month stay of the suspension of license #11446 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: the (5) five year time period for the practice of pharmacy by Meyer under the original terms and conditions of the *Order* is deemed to begin on January 14, 2004. All previous modifications to the original terms and conditions of the *Order* are hereby removed and vacated by the board.
