On April 7, 2004, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Kevin M. Pampuch for an order granting a stay of suspension pursuant to the *Final Decision and Order* ("*Order*") in the above-captioned matter entered on March 10, 1999. Also requested was a reduction in the frequency of urine screens from eight times (8x) per month to six times (6x) per month.
