On April 7, 2004, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Kevin M. Pampuch for an order granting a stay of suspension pursuant to the *Final Decision and Order* (“*Order*”) in the above-captioned matter entered on March 10, 1999. Also requested was a reduction in the frequency of urine screens from eight times (8x) per month to six times (6x) per month.

Based upon the foregoing,

IT IS HEREBY ORDERED, that Kevin Pampuch is granted a three month stay of suspension of license number 12635 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED, that the request for a reduction in the frequency of urine screens from eight times (8x) per month to six times (6x) per month, is granted.
